To whom does this leaflet apply?

People who shall be employed in Germany as professional drivers for the transportation of goods or in passenger transportation with motorbuses.

If you are a professional driver for a foreign employer and only enter Germany for short-term transportation of goods (up to 90 days in 12 months), this information sheet is <u>not</u> relevant for you.

Please note:

- Due to the high workload and in order to ensure equal treatment of all applicants, the visa section can only accept applications for processing in the requested form.

- Please refrain from inquiries about the status of the application. Status inquiries do not speed up the visa process.
